Here is the list of documents that you need to determine eligibility for the program. You will be required to bring these documents to an eligibility meeting.

1. Picture ID (09-10 current School ID, California ID, Driver's License or Passport)
2. Social Security
3. Birth Certificate
4. Proof of Income for each family member (need pay stubs from the last six months- October 2009- March 2010)
5. Proof of family size (picture IDs, birth certificates, marriage certificate or social security)
6. Proof of Address (envelope or mail posted in the last 30 days with the applicants name not your parents)
7. Resident Alien Card/ MICA, U.S Passport, and /or Naturalization Certificate if applicable
8. If under 18, need to be able to obtain a work permit for the summer
9. If over 18, need to provide a negative TB test from the last 4 years
10. If a male over 18, must be registered with Selective Services
